Helped build the movement to end child abuse & slavery in Haiti by providing technical support to 46 existing volunteer neighborhood Child Protection Brigades in Port-au-Prince. Organized and built the capacity of 300+ survivors' network members. supporting their efforts to raise awareness and intervene to protect children. Seven children were reunified with their parents. Began developing programming to introduce economic activities for survivors. Throughout the year, survivors met regularly for peer support sessions. They received advocacy training and were supported to conduct advocacy activities and raise awareness in their neighborhoods.

Hurricane Matthew hit communities hard in October 2016, interrupting activities and destroying livestock and crops. Provided training and support to 775 individuals, including 194 women, 319 girls, and 68 staff of technical support organizations. About Beyond Borders

Beyond Borders supports Haitians to build movements to:

- 1) End child slavery and other practices that harm children;
- 2) Guarantee universal access to quality education;
- 3) End violence against women and girls (VAWG); and,
- 4) Promote economic justice and sustainable livelihoods.

Since 1993, Beyond Borders' complementary programming and work with local partners has reached some of Haiti's most vulnerable people in more than 76 urban and rural communities located in the Southeast, West, and Central departments of Haiti. Beyond Borders employs 35 staff, operating out of five offices including its head office in Washington, DC and offices in Jacmel, Port-au-Prince, and Ti Palmis (LaGonâve).

Beyond Borders promotes dialogue, participation, and respectful exchange by facilitating communities to develop solutions to challenges they face. Beyond Borders supports networks of individuals and communities addressing the educational needs and human rights issues of groups traditionally marginalized and without access to basic services.

FY 2017 Achievements

The Movement to End Child Slavery

Beyond Borders works to catalyze a broad social movement for children's rights, with a special focus on stopping the practice of child domestic slavery. In remote, rural regions of Haiti, Beyond Borders' Model Community Initiative accompanies communities to protect, educate and feed their children in order to stop the flow of children into child domestic slavery. In urban neighborhoods, it works to build local volunteer structures to help children access protection services when needed, and to help children living in child slavery find their way home. In both urban and rural communities, Beyond Borders is supporting an emerging network of more than 500 adult survivors of child slavery who are using their voices to end the practice and intervening on behalf of children in need.

During the year, Beyond Borders' rural interventions impacted the lives of more than 11,000 women, children, and men in 14 communities across the island of LaGonâve. Beyond Borders is now advancing the rights of children in 16 communities on LaGonâve and eight communities in Port-au-Prince.

Cumulatively, 63% (193/306) of children living away from home in child slavery have returned home across nine rural communities.

Achievements for the year include:

Trained 702 child rights activists and held five Open Space sessions to mobilize local action. The most significant changes reported by participants were: do not send children into child slavery; no longer use corporal punishment to discipline children; and no longer mistreat children.

Trained and inaugurated five new Child Protection Brigades. Child Protection Brigades helped children enroll in school, procure birth certificates, access healthcare, and access protection when in danger. Child

Protection Brigades collaborated to boost collective economic capacity to conduct protection activities, and supported 200 children through children's clubs; distributed school supplies, uniforms, and shoes to 1,052 children; and paid tuition for 40 students. Nine Child Protection Brigades conducted activities to raise awareness and advocate for children's rights, reaching 2,378 residents.

Mobilized adult survivors of child slavery, inaugurating three new branches to increase the LaGonâve network by 140 members (total 223). Port-au-Prince programming focused on building capacity of 300+ survivors' network members. In urban neighborhoods, network branches raised awareness and intervened to protect children. Seven children were reunified with their parents. Beyond Borders is developing programming to introduce economic activities for survivors. Throughout the year, survivors met regularly for peer support sessions. They received advocacy training and were supported to conduct advocacy activities and raise awareness in their neighborhoods.

Promoted enforcement of Haiti's anti-trafficking law, printing 5,000 informational pamphlets, holding workshops with 44 religious leaders, Open Space sessions in nine communities, and supported Child Protection Brigades to hold advocacy meetings with justices of the peace.

The Movement for Universal Access to Quality Education

Since 2003, Beyond Borders has been developing unique and innovative approaches to addressing lack of access and quality of education in rural communities. Interventions include community organizing toward strong school networks that lead to addressing barriers to education and to improvements in the quality of education through teacher training. Additionally, Beyond Borders has extensive experience implementing alternative approaches to ensuring access for older, under-schooled youth through Accelerated Education classes, and a Tuition Match approach, which builds on community initiative by multiplying local inputs through matching grants.

On LaGonâve Island, Beyond Borders works in collaboration with the Matènwa Community Learning Center (MCLC), whose education methods were proven effective in a December 2014 MIT study at increasing student success. Beyond Borders is partnering with MCLC to scale these promising methodologies through outreach programming with schools across the island of LaGonâve.

As a result of Beyond Borders' programming in five LaGonâve communities, school attendance by school-age children increased from 83% at baseline to 97% at midline, a significant movement toward achieving universal access.

Achievements during the year include:

Held nine one-day workshops and three days of residential training for more than 100 teachers from 36 schools; classroom observations revealed increased student participation;

Trained and supported 50 teachers at 25 schools to facilitate Open Space sessions to increase parent engagement;

Distributed subsidies to 25 schools and launched a pilot tuition match program with 3 schools, conducting workshops to build schools' capacity to budget, report, and manage finances;

Supported 26 schools to provide students with low-cost access to textbooks through the book bank

project.

Provided specialized accelerated education classes to 75 over-aged, under-schooled youth;

Supported the LaGonâve school network to conduct advocacy initiatives to promote the use of Haitian Creole and its use as language of instruction.

After 44 years of leading schools, in the one year I've been participating in MCLC's programming, I've learned so much, particularly how to better lead in a school. I have completely changed how I treat the children and staff. I don't use corporal punishment in my schools anymore, thanks to the other nonviolent classroom management methods I learned from MCLC. I not only apply what I've learned at Holy Family, but at Saint Bernadette School as well.

The Movement to Promote Economic Justice and Sustainable Livelihoods

Beyond Borders recognizes that extreme poverty, especially in rural areas, contributes to the vulnerability of children. As such, Beyond Borders has invested in adult literacy training, training in sustainable agriculture, and rural economic development. Beyond Borders is using three primary approaches in this work:

1. Agro-literacy classes for adults and farmers engage residents in daily literacy classes and periodic agricultural workshops to introduce sustainable farming techniques.
2. School and family gardens produce income and improve nutritional variety for schools and families. Also, students and parents gain a range of new, sustainable farming skills.
3. The PAMM Program, Beyond Borders' adaptation of the Graduation methodology (pioneered by BRAC), helps destitute families develop sustainable livelihoods and overcome critical vulnerabilities around housing, food security, health, and schooling. Beyond Borders' adaptation includes a child welfare aspect.

To implement literacy and Graduation model programming, Beyond Borders works in partnership with AAPLAG, a local LaGonâve community organizers' association. Beyond Borders collaborates with MCLC to implement the school and family garden programming. Achievements for the FY 2017 year include:

Provided literacy classes to 288 women and men, 95% of whom passed assessments by demonstrating basic literacy skills;

Conducted six agricultural outreach workshops with 450 farmers;

Progressed with Graduation programming, despite devastation caused by Hurricane Matthew in October 2016 which interrupted activities and destroyed livestock and gardens of residents. Beyond Borders and AAPLAG helped 80 participating families by replacing lost assets and continuing with home repairs, and launched programming with a second, larger cohort of 151 families in early 2017, due to assessed need.

Conducted a 12-month evaluation of 80 Cohort 1 families; The 12-month evaluation of Cohort 1 families revealed:

- o Ninety percent (90%) families reported eating at least one hot meal per day.
- o Forty-four percent (44%) reported planting gardens.
- o Twenty-seven percent (27%) reported that they've planted fruit trees.

- o No PAMM participants reported children with malnutrition in the home.
 - Delivered "Confidence Building Training" to 80 Cohort 1 participants;
 - Distributed 459 productive assets (primarily livestock), weekly cash subsidies, and water filtration systems to 151 Cohort 2 participants;
 - Made home repairs or reconstructed dignified homes for 64 families (ongoing);
 - Provided monthly health clinics, made available an emergency health care fund, and accompanied 11 village committees to support participants.
- o Conducted a 6-month evaluation of Cohort 2 families, which revealed:
 - o Seventy percent (70%) of families experienced profits generated by productive assets.
 - o Sixty-two percent (62%) of participants contribute to savings accounts regularly.
 - o Fifty-six percent (56%) of families had meat to eat that week.
 - o Fifty-eight percent (58%) of participants purchased livestock or another new asset since being in the program.
- o Trained and supported 36 schools in school garden management, conducting 176 agricultural coaching visits and restocking tool and seed banks; teachers integrated gardening activities with core subject lessons;
- o Trained, coached and provided materials to 31 families to plant organic vegetable gardens.

I will never stop thanking MCLC for helping me create a garden at my school. From our school garden, we just sold vegetables for 11,040 HTG (\$184US), and that's without counting the vegetables we gave away to students and teachers. This revenue helps us pay our teachers' salaries. This is all thanks to MCLC giving us the support and techniques to make the school garden.

The Movement to End Violence Against Women and Girls: Rethinking Power Program
Beyond Borders' Rethinking Power program engages communities in driving social change process to prevent violence against women and girls (VAWG) and HIV. The Rethinking Power program also provides technical support to local organizations to implement community mobilization in their own communities. Beyond Borders implements a number of evidence-based methodologies to engage communities in self-led processes of transformation. Two promising methodologies help to engage communities to prevent Violence against Women and Girls (VAWG):
" SASA!: A phased community mobilization methodology created by Raising Voices to prevent VAW, proven to cut the risk of intimate partner violence in half.
" Power to Girls: A phased community mobilization approach created by Beyond Borders to address violence against girls, focusing on girls' safety, voice and agency.

This year, Beyond Borders launched SASA! and Power to Girls in eight new communities in Haiti's Southeast Department. Additionally, SASA! was implemented in five communities on the island of LaGonâve, alongside child rights, education and livelihoods activities. Altogether, the Rethinking Power program provided training and support to 775 individuals, including 194 women, 319 girls, and 68 staff of technical support organizations. Highlights include:

Supported five original SASA! pilot communities in the Southeast Department with visits to communities and advocacy networks.

Engaged eight new communities in the Southeast Department to implement Power to Girls and SASA!; continued SASA! implementation in five LaGonâve communities; engaging 16 girls' group mentors, 116 community activists, personnel at three schools, theater troupes, journalists, religious and community leaders, health workers, and women's groups.

To scale the work, trained and supported 13 organizations to implement SASA!; conducted technical support visits to partners, and facilitated exchange between them. Beyond Borders is close to completing its training curriculum to integrate Power to Girls into technical support programming to launch in 2018.

Beyond Borders launched its collaboration with The Global Women's Institute (GWI) at George Washington University and local partner IFOS to research the impact of SASA! and Power to Girls, as implemented by Beyond Borders in eight new communities in LaVallée in the Southeast Department. Baseline data was collected in LaVallée and comparison community Marigot in early 2017. Midline will be conducted in 2018.

Beyond Borders also launched a collaboration with the University of California at San Diego (UCSD) to study the adaptation and implementation of SASA! in Beyond Borders' original five 2010-2015 SASA! pilot communities, to learn what inputs make it possible to scale SASA! in another place. An amendment to the partnership adds an additional evaluation of Beyond Borders' technical support offerings on SASA!.

Beyond Borders conducted rapid assessments in communities to gauge community readiness to move into the next phase of SASA! This table shows how social norms are changing in one LaGonâve community.

Baseline versus Midline, Nan Kafe, LaGonâve Island

Percent people who say it's a form of violence for men to exercise heavy control over family finances. 45% 68%

Percent people who believe a woman has a right to not have sex with her husband if she doesn't want to. 32% 68%

Percent people who know that a woman's chance of contracting HIV increases if her partner has other sexual partners. 57% 89%

Percent people who believe a woman should accept verbal abuse, humiliation, and beatings to avoid separation and keep the family together. 55% 15%

Before the SASA! training, I thought that if a man cussed out his wife and his wife screamed back at him, that his wife was in the wrong, and her husband should beat her. But, after all the SASA! training I've received, I know that there is no one in a home who has a right to hit or curse at the other. I used to think that women were to blame for the violence that was done to them. But now I know that the reason men beat women is imbalance of power. For me, after SASA! training, my home has come to have less violence, and I'm working for no violence in my home and in the homes of my neighbors.
