GRADUATES REPORTED THAT: 1) THEY ARE NOW USING DIALOGUE AS THE PRIMARY FORM OF DISCIPLINE WITH THEIR CHILDREN (91%); 2) THEY DO NOT BELITTLE OR BULLY THEIR CHILDREN (OR OTHER CHILDREN) ANYMORE (83%); AND 3) THAT THEY HAVE GREATER LOVE/AFFECTION FOR THEIR CHILDREN AND/OR CHILDREN IN GENERAL (82%). STRUCTURES CONDUCTED ORGANIZATIONAL SELF-ASSESSMENTS TO IDENTIFY CAPACITY-DEVELOPMENT NEEDS TO SUSTAIN THEIR MOVEMENT-BUILDING EFFORTS, INCLUDING MOBILIZING NEW COMMUNITY STAKEHOLDERS AND CONDUCTING ADVOCACY. MULTI-DAY TRAINING WORKSHOPS WERE PROVIDED TO STAFF FROM ALL SEVEN SCHOOLS ON SCHOOL ADMINISTRATION, CLASSROOM MANAGEMENT AND PREPARATION, AND LITERACY. ALL 21 TEACHERS FROM SEVEN SCHOOLS ARE USING

AT LEAST TWO NEW TEACHING TECHNIQUES THEY LEARNED OVER THE COURSE OF THE 2 -YEAR PROGRAM; FUNDS ALSO SUPPORTED INITIATIVES WITH 30 OTHER SCHOOLS AND THE LARGER NETWORK OF SCHOOLS THAT HAVE GRADUATED FROM THE PROGRAM IN PAST YEARS.
